

Global Adult Tobacco Survey, 2010 & 2017





Prevalence of current tobacco smoking by gender, GATS Ukraine 2010 and 2017









Tobacco Control Progress

Noticed any cigarette advertisement, sponsorship or promotion in the past 30 days by age group, GATS Ukraine 2010 and 2017





Current smokers thought about quitting because of health warnings on cigarette packs, and adults noticed anti-cigarette information,
GATS Ukraine 2010 and 2017






Global Youth Tobacco Survey 2005, 2011, 2017






Window of Opportunity for Tobacco Tax Increase






The Law on a 7-year Schedule to Increase Tobacco Taxes by around 20-30% in 2018-2025, adopted in 2017

Overturning



Experts of Transparency International Ukraine analyzed ties between the government officials and the tobacco companies.





WEAKENING THE TOBACCO INDUSREY POWER NETWORKS

- Hard-hitting campaign to damage the industry reputation
- Promoting transparency
- Code of conduct for Government and elected officials
- Limiting interactions with the TI
- National legislation on FCTC 5.3 and the Guidelines and Enforcement Mechanism
- EFFECTIVE JUSTICE SYSTEM & ANTICORRUPTION LEGISLATION



Lessons Learned

- Let decision-makers be the messengers
- Build long-term relationships with media,
 MPs
- Challenge & empower policy makers
- Acting from a position of strength
- Simple wording of complex data/messages
