
Theme of the Special Issue

The goal of this Special Issue is to collect research and theoretical models that investigate when, how, and why people engage in violence. We welcome papers concentrated on interpersonal violence as well as on group violence. We would like to integrate research from various areas of psychology, such as clinical psychology, personality and individual differences, as well as social and political psychology. This Special Issue welcomes submissions based on experimental studies, surveys, clinical case studies, as well as review papers, which may address (but are not limited to) the following topics:

- Socioeconomic factors related to violence
- Personality factors and violence
- Personality disorders related to engagement in violence
- Sexual violence
- Evidence-based interventions
- Evolutionary basis of violence
- Close relationships and intimate violence
- School and workplace violence
- Gender based violence
- Child abuse and neglect
- Ideologies, narratives, social representations and group violence
- Populism, nationalism and radical violent actions
- Religion, fundamentalism and violence
- Social change, minority rights and radical violent actions
- Media, technology and violence

Types of the articles for the Special Section

Current Issues in Personality Psychology (CIPP) publishes high quality original articles and reviews of recognized scientists that deal with personality theories and research from the perspective of social science, law and medicine. CIPP promotes the study and application of personality psychology to various domains of individual and social functioning.



In particular we are interested in such topics as the role of personality in interpersonal relations; individual differences; personality disorders; personality development; personality and behavior dynamics; quality of life and well being; the interplay of culture and personality; biosocial bases of personality; and personality assessment and diagnosis. However, we are open to innovative research and new conceptual reviews in the field of personality science.

We welcome various article formats, such as **Research articles** (up to 7500 words), **Review articles**, or **Case Reports**. For this special issue we especially encourage Authors to submit **Short Research Reports** (up to 3200 words). See instructions for Authors here:
